

### **Basic Criteria to participate**

The following are a set of minimum criteria that those wishing to participate in the "Regional Consultation Youth, Peace and Security: Voices of youth in Latin America and the Caribbean" must possess:

- Youth between 18 and 29 years old; as explicitly stated in Security Council Resolution 2250.
- Young people interested in participating in the consultation should have broad work experience on issues related to peace and security at the local, national, regional or global level. Some work topics that we are particularly looking for include:
  - Development Cooperation
  - Humanitarian Action
  - The peace process
  - o Social cohesion and social fabric recovery
  - Local and national governance processes
  - o Activism through civil society movements: Advocacy
  - Prevention of youth violence: gangs and gangs
  - o Reconciliation mechanisms and access to justice
  - Citizen Security
  - Gender violence, especially sexual violence
  - Promotion of gender equality
  - Promotion, awareness and defense of human rights, with emphasis on sexual and reproductive rights

#### Some premises

The Organizing Committee of the Consultation will guarantee equal opportunity to participants regardless of their status or origin, and will always seek the balanced presence of all countries in the region. In this sense, it will advocate for an equitable and inclusive presence of young people, ensuring adequate participation of young women, as well as young people from rural and urban environments, from different socioeconomic backgrounds, youth of African descent, indigenous youth, disabled youth, LGBTI youth, as well as refugees, displaced persons and stateless persons.

1. Official Identification	Passport with a minimum validity period of 6 months * Failure to comply with this requirement will prevent the participant from traveling to the

3. Type of Participation	<ul> <li>If the applicant is participating on an individual level, he/she must present an official identification</li> <li>If the applicant belongs to a civil society organization: he/she must provide a letter proving his/her organizational representation</li> </ul>
4. Other requirements	<ul> <li>Summary of activities or achievements aimed at preventing violence, combating inequalities and promoting a culture of peace</li> <li>Professional references of other young people with whom they have worked or shared some experience</li> </ul>

5. Motivational message	<ul> <li>(1 page maximum)</li> <li>Explanation of motivation and interest in participating in this consultation and why he/she should be selected to participate. This can be done through various formats: <ul> <li>A. LETTER (1 page maximum)</li> <li>B. VIDEO AND AUDIO</li> </ul> </li> <li>Presentation of a video or audio with a maximum duration of 2 minutes where the perceived challenges in the region to generate a peaceful coexistence are addressed, as well as the opportunities to generate a sustainable peace</li> <li>The material can be recorded in English, French, Dutch, Spanish and Portuguese</li> <li>The applicant must appear and speak in the video or audio recording and upload</li> <li>Imagination and creativity will be valued</li> <li>If candidates do not have a camera they can use their phones</li> </ul>

	Any candidate who does not comply with these characteristics will be disqualified
