Panama is a family duty station and is considered to be a safe place to live, however, like in any city around the world, it is always good to be aware of your surroundings and to be alert. There is a wide range of goods available in Panama and many modern shopping complexes as well as department stores, designer stores, 24-hour grocery stores. There are suitable residential areas, accommodation options, good hospitals, schools, universities, banks and wide selection of restaurants and entertainment. Panama offers many options for interesting weekend activities. There are Beaches, Mountains and National Parks in the rainforest that it is said have the widest range of flora and fauna the world.

Panama does not have any serious health concerns to worry about, however it is important to note that in some areas such as the Darien province, it is recommended to take precautions for malaria. The Centers for Disease Control website also recommends the yellow fever vaccination for travel to Darien province and the San Blas islands.

Weather: Panama has two seasons, the dry season which is from January until late April or early May and the rainy season which is the rest of the year. The daytime temperature ranges between 80- and 90-degrees Fahrenheit with the evenings being cooler by 5 to

10 degrees. The average humidity is 70%.

Panama is a unique country and UNFPA is a unique (humanitarian) operation. UNFPA is formally named the United Nations Population Fund. UNFPA calls for the realization of reproductive rights for all and supports access to a wide range of sexual and reproductive health services – including voluntary family planning, maternal health care and comprehensive sexuality education.

Since UNFPA started its work, the world has seen progress: The number and rate of women dying from complications of pregnancy or childbirth has been halved. Families are healthier. Young people are more connected and empowered than ever before.

But too many are still left behind. More than 760 million people are mired in extreme poverty. Sexual and reproductive health problems are a leading cause of death and disability for women in the developing world. Young people bear the highest risks of HIV infection and unintended pregnancy. Many millions of girls face the prospect of child marriage and other harmful practices, such as female genital mutilation (FGM).

Much more needs to be done to ensure a world in which all individuals can exercise their basic human rights, including those that relate to the most intimate and fundamental aspects of life. In 2018, UNFPA launched efforts to achieve three transformative results, ambitions that promise to change the world for every man, woman and young person:

The global epidemic of COVID-19 is wreaking havoc on a wide array of health, economic, social and personal decisions. However, what may be lost in the chaos among other effects and dangers is the specific impact on sexual and reproductive health and rights (SRHR). Policymakers, providers and advocates must be aware of the broad links between the global outbreak response and sexual and reproductive health and rights in order to prepare to mitigate the impact.

Sexual and reproductive health and rights underpin gender equality and are pivotal to good health. Evidence shows that when women are denied access to contraception, safe abortion and post-abortion care, maternal mortality rates rise. SRHR services are essential health care and must be accessible. A continued focus on the neglected areas of SRHR must also be part of the global response to COVID-19.

UNFPA is working to ensure an integrated response to the virus that includes SRHR, with a particular focus on the following areas: maternal and perinatal health care, family planning counselling/contraceptive services, STI and HIV, comprehensive contraceptive

care, SRHR for adolescents and youth, including comprehensive sexuality education (CSE), and advocacy for SRHR.

This also includes the clinical response to sexual abuse, addressing SRHR in a humanitarian crisis, and gender-based violence.

Countries in Latin America and the Caribbean continue to grapple with political, cultural, social and programmatic barriers to eliminating new HIV infections, AIDS-related deaths and discrimination. Key issues such as stigma and discrimination, access to services and the protection of human rights persist. Gay men and other men who have sex with men and sex workers are among the most vulnerable key populations in the region that continue to suffer from systemic stigma, abject social exclusion and marginalization. COVID-19 affects the health systems response, which puts at risk people living with HIV/AIDS. UNFPA's approach to HIV is based around three strategies: promoting human rights and reducing inequalities, integrating HIV responses into sexual and reproductive health care, and preventing sexual transmission of HIV.

The purpose of this consultancy is to support the work on SRH including HIV/AIDS within the LAC region's response to COVID 19.

Overall Objective:

• Substantively contribute to the effective management of UNFPA's sexual and reproductive health activities including the work on HIV with a focus on the current COVID-19 pandemic in LAC through collaborative work with UNFPA, partners and COs.

Technical/programmatic activities:

- Analyze and assess relevant political, social economic and epidemiological trends in the field of sexual and reproductive health including HIV/AIDS, in response to priorities defined by the regional office.
- Support implementation of the SRH Strategy ensuring their linkages and applying the integrated SRHR approach and ensure that technical knowledge is updated, generated, collected and disseminated for effective technical and policy dialogues.
- Keep abreast of new policy developments and strategies analyzing policy papers, strategy documents, technical updates in the field, and prepare briefs and inputs for policy dialogue, development frameworks and preparation of reports.
- Support the development of training materials on the subject and participation in training spaces that are defined.
- Support the preparation of project summaries, conference papers, talking points as needed;
- Support project implementation establishing collaborative relationships with implementing partners (IPs), facilitating timely and
 efficient delivery of project inputs.
- Help create and document knowledge about current and emerging reproductive health trends by analyzing programme, projects, strategies, approaches and support documentation of best practices in the field and ongoing experience for lessons learned.
- Assist advocacy and resource mobilization efforts of LAC Regional Office by preparing relevant documentation, i.e. project summaries, conference papers, speeches, donor profiles, and participating in donor meetings and public information events.
- Provide technical assistance on issues of prevention, care and response to HIV/AIDS, within the UNFPA LACRO regional office, to UNFPA country offices, UN agencies and government, academic and civil society counterparts.
- Contribute to the development, implementation and monitoring of regional strategies on COVID 19 and HIV/AIDS;
- Coordinate programmatic activities according to the annual work plans and approved budget;
- Follow up with countries having received HIV UBRAF country envelopes and respond to critical issues.
- · Assist in the preparation of reports as requested.
- Support the SRH Advisor in the implementation of the programmes under her/his responsibility.

Note on novel coronavirus - COVID-19.

The rapidly changing nature of novel coronavirus COVID-19 has placed significant and increasing restrictions on the freedom of movement of people across the globe, within countries and across borders. Such restrictions make it very difficult for international UN Volunteers to begin their assignments at their assigned duty station and UNV cannot guarantee assignments will proceed as normal.

Candidates for international UN Volunteer assignments during this period may be exceptionally granted alternative working arrangements to work from their place of recruitment until restrictions are lifted. This is at the discretion of the host entity. Candidates proceeding to interview are recommended to discuss the likelihood of travel and possible alternative arrangements with the host entity. If selected, candidates should carefully consider the circumstances before accepting UNV's offer.

In cases where the UN Host Entity partner has requested the UN Volunteer to perform their assignment remotely, the Post Adjustment Multiplier (PAM) and related entitlements to be paid may be adjusted to the temporary duty station from where the UN Volunteer has been requested to work if requested by the UN Host Entity.

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,651. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.

Supervision, induction and duty of care of UN Volunteers

UN Volunteers should be provided equal duty of care as extended to all host entity personnel. Host entity support to the UN Volunteer includes, but is not limited to:

- Introductory briefings about the organisation and office-related context including security, emergency procedures, good cultural practice and orientation to the local environment;
- Support with arrival administration including setting-up of bank accounts, residence permit applications and completion of other official processes as required by the host government or host entity;
- Structured guidance, mentoring and coaching by a supervisor including a clear workplan and performance appraisal;
- Access to office space, equipment, IT support and any other systems and tools required to complete the objectives of the assignment including a host entity email address;
- Access to shared host entity corporate knowledge, training and learning;
- Inclusion of the volunteer in emergency procedures such as evacuations;
- Leave management;
- DSA for official travel, when applicable;
- All changes in the Description of Assignment occurring between recruitment and arrival or during the assignment need to be formalized with the United Nations Volunteer Programme.
